Gretna Is Going Green(er)!

As a Community Housing Development Organization (CHDO) for the City of Danville, Telamon-Gretna has been helping to create affordable housing since 1996. To date they have rehabilitated twenty-five homes in the City of Danville. In 2000, in partnership with the City of Danville and the Danville Redevelopment and Housing Authority, Gretna also built three new infill houses in the inner city. As with all the other houses they build or rehab, in or out of the city, these were set aside for low to moderate income individuals.

It is clear that rehab and infill construction in the city also helps to revitalize the older neighborhoods. What is not so evident, however, is that the process of rehabilitation is inherently green. The rehab and reuse of existing properties or infill construction in a city, helps conserve resources and existing infrastructure. It is anti-sprawl.

However, the use of green building techniques have until recently been confined to their new construction projects. For example, two of the six homes in the Beverly Heights Project in Pittsylvania County included green building elements such

as conditioned crawl spaces, sealing gaps or openings around electrical switch plates, electric lines and pipes, and installing smaller septic tank drain lines. There is no reason though why green building and related energy efficiency cannot be incorporated into the rehab work as well.

So, after examining cost and cost effectiveness (both to Telamon and to the future homeowner), Gretna "greened" the rehab specifications for a 1960's house currently being rehabbed in Danville. The greening includes elements such as the use of zero VOC paints and adhesives, installing low-e windows, refurbishing wood floors, installing energy efficient light bulbs, and incorporating native species into the landscape. All of these improvements will help maintain a healthy indoor environment as well as keep the future owner's home maintenance costs down.

Telamon-Gretna plans to green rehab at least one more home in the City of Danville in the next year. Gretna's Homeownership Project Manager, Robin Roark, and Housing Counselor, Lynita Falls, will be attending an EarthCraft Single Family Home Construction workshop with

Deputy State Director, Mayra Nickerson, in November. Their world is looking greener by the minute. Go Gretna!

of being a renter and later purchased a condo.

"Everyone needs a safe haven with security and owning a home provided that for me," said Schulyer. He indicated that in today's economy, when some people have seen home ownership slip away, it is good to celebrate those who are looking for the American Dream of home ownership and who are achieving that dream. Schulyer talked about how Congress has passed the Stimulus Bill offering tax incentives up-to \$8,000 to first time homebuyers who purchase housing before December 1, 2009, and the Making Homes Affordable Bill that works to help homeowners remain in their homes.

Byron Waters from Rural Development spoke on the partnership between Telamon and Rural Development and how the two agencies work together to help make homeownership affordable. Waters also complimented the quality of the construction of the houses that were built by Telamon. "Owning a home is the foundation of America's individual freedom," stated Waters. It is wonderful - the classes that Telamon offered have taught me ways to stick to a budget. If you want to be a homeowner, stick to your plan. I'm not going to mess that up. Mary Beth White spoke about the past six months and how she got to this point.
